## A MESSAGE FROM THE NMAPTA PRESIDENT

NMAPTA Members:

I hope this e-mail finds you all well and at home with your loved ones. I would like to give you a brief update on what NMAPTA has been doing on behalf of our members in regards to COVID-19 and the Public Health Orders that have been released by the State. We are aware there has been confusion, as the language in the orders have not been clear. I have sent the Governor two letters seeking clarity on the last two orders, one seeking clarification on "walk in care health facility" and the second to request support for telehealth and to mandate that private payers pay for it. NMAPTA is unable to give legal advice to businesses or individual therapists on how to interpret the Public Health Orders. All licensees must abide by the Orders and business owners need to make their own decision on interpretation, consulting their legal counsel on the best way to move forward. What we can do is seek clarity where there is confusion. We can also share information about telehealth, payers, etc....
